





Single Colour Flexible Tape

12V DC single color, flexible LED tape with 3M self-adhesive tape. Distance between LEDs of 0.6'' / 16.6mm and cut points every 3 LEDs (2.0'' / 50mm). Very low power consumption of 1.5W per ft. Requires 12V DC Constant Voltage LED driver. Multi-purpose LED tape that delivers discreet illumination with a small profile.

Maximum run of 32.8 ft / 10 m, any length over 32.8 ft / 10 m must be run in parallel. Very low power consumption of 1.5 W/ft. A 12 V DC Constant Voltage LED driver is required (see driver options table). Reel length 16 ft / 4.87 m. Dimmable with 0-10 V and MLV Dimmers with the suitable Aurora driver offering.
